#### **INTERPOL** – a global organization

- ICPO- INTERPOL: International Criminal Police Organization
- Created in 1923, INTERPOL is the world's largest international police organization, with 190 member countries
- General Secretariat in Lyon, France,
  6 Regional Bureaus, 1 Liaison
  Office, and SRIUN in New York, SRIEU in Brussels & SRIAU in Ethiopia.
- Four official languages: Arabic, English, French and Spanish.
- A National Central Bureau (NCB) in each member country

#### **NATIONAL CENTRAL BUREAUS**

- Are the lifeblood of INTERPOL
- 190 in total creating a global network
- Headed a designated person
- National security Officer (NSO) appointed
- Central point from where other LEAs may be connected.



#### **NTERPOL'S POLICING CAPABILITIES**

- Exchange of information Secure Global Communication System I-24/7, including direct access to information
- Compiling, clearing, and structuring of information – INTERPOL databases
- Capacity building and training
- Dissemination of information/Operations INTERPOL Notices and diffusions.
- Proactive collection of information open sources monitoring and communications



## **TYPE of NTERPOL Notices**



To seek provisional arrest with a view to extradition



To collect info on persons or activities related to a criminal matter



To provide warning or criminal intelligence



To help locate missing persons, especially minors



To seek information about unidentified bodies



Issued for entities and individuals, sanctioned by UNSC



To warn of a serious and imminent threat to public safety



To provide modus operandi, methods used by criminals

# Promotion of police cooperation in Environmental crimes (Illegal exploitation of natural resources).

- Natural resources in ICGLR member countries includes minerals, flora and fauna.
- Minerals e.g. Gold, oil, Tanzanite, Tantalum (Coltan), Tin, Tungsten (Wolframite), Cassiterite, Uranium, Cobalt metal, Copper and Nickel hydroxide.
- Flora: Hardwood and sandal wood.
- Fauna: wildlife and their products.



Tanzania police and Wildlife authorities arrested Huang Quin, Chen Jin Han and Xu Fujie in 2013 with 1885 Kgs (Tsh 5,435,865,000).

On 16/11/2015, Hu Liang, Chen Jianli, Xiao Shaodan and Song Lei arrested with 11 rhino horns. Collaboration with LATF.


