### 12-13 November 2018

Thank you for joining the 3<sup>rd</sup> Meeting of the Great Lakes Judicial Cooperation Network, convened by the ICGLR, hosted by the Government of Uganda, and organized by United Nations Office of Drugs and Crime jointly with The Office of Under Secretary General based at the UN Nairobi. Kindly find below detailed information on logistics.

### Time and Venue:

- Time: The workshop will begin at 8:30am on Monday 12<sup>th</sup> November 2018 and will end at 6:00pm on Tuesday 13<sup>th</sup>November 2018.
- Reception for Delegates: This will take place on 12<sup>th</sup> November 2018 from 19:00 hrs
- Reception for Civil Society and invited guests: This will take place on 13<sup>th</sup> November 2018 from 19:00 hrs
- Venue: Speke Resort, Munyonyo

All participants will be entitled to the conference package including (i.e. morning/afternoon tea/coffee and lunch).

### Transportation:

- (a) Local Participants: A shuttle will be provided by Speke Resort to and from a designated point in Kampala CBD.
- (b) International participants: UNODC has made available a round-trip flight ticket to delegates to enable them attend the meeting. In addition, airport pick and drop shuttle service has been made available by the hotel. Upon arrival, delegates should locate hotel staff holding a GLJCN banner who will direct

them to the waiting shuttle. Travel itineraries have been shared with the hotel to facilitate timely pick and drop off services. In the event of changes in flight timings kindly contact the undersigned.

The hotel is located in Munyonyo 38.7 kms from Entebbe International Airport which is 42 minutes' drive in normal traffic. It's 16.1kms from Kampala.

#### **Daily Subsistence Allowance (DSA):**
